
PUTTING YOUR CLAIMS IN THE EXPRESS I ANE

- · RSA client for minimum one year and claims-free
- Applies to both Personal and Commercial Insurance policies
- · The total amount claimed is less than \$25,000
- · Fewer than 25 items
- Items will be valued through online verification (i.e., Claims Network, CodeBlue, ReClaim, as well as some general retailers' websites)
- Payment is based on full replacement cost (subject to applicable policy deductible)
- · No signed proof of loss required
- · No formal statement required
- · No additional investigation required for the claim being presented by the client
- Explanation letter will be sent to the insured with payment, which helps eliminate return calls
- Property Express claims may also be available for proportions of a larger loss (e.g., once a building loss is concluded, we may be able to fast-track the contents portion of the claim if it meets the above criteria)

PROPERTY EXPRESS ELIGIBILITY— BUILDING DAMAGE (WIND/WATER/ VANDALISM/THEFT)

- · RSA client for minimum one year & claims-free
- · No special investigation required
- · Applies to both Personal and Commercial Insurance policies
- · The total amount claimed is less than \$25.000
- All assignments through Contractor Connection and estimates reviewed through XactAnalysis
